Hualapai Mtn. Rd., Kingman, AZ 86401. Board members or other participants may attend by telephonic conference. The following topics and any variables thereto will be subject to Board consideration, discussion, approval, or other action. • Chairman of the Board, Ron Kutil called the meeting to order at 6:00 p.m.

APPROVAL OF MINUTES

• From 06/18/2025 regular meeting. Karen Gibas motioned to approve the regular meeting minutes of 06/18/25 with typo corrections. Chuck Osterman 2nd the motion. All in favor, motion carried.

- Approval of June 2025 P&L Detail Report, Budget vs. Actual Report, Treasurer's Report and PR Statement. Karen Gibas motioned to approve the financial reports for June 2025. Chuck Osterman 2nd the motion. All in favor, motion carried.

PLFD FIRE CHIEF'S REPORT

- a) **Operational Report.** Fire Chief/Rick Schimkat reported one (1) Medical Call, two (2) Bush Fire calls, one (1) agency assist, and two (2) resident assist with the use of chain saws.
- b) **Fire Chief's Report.** The governing body may not propose, discuss, deliberate or take legal action on this matter unless the specific matter is described in detail. Therefore, action taken as a result of the Chief's report will be limited to directing staff to study the matter or scheduling the matter for further consideration and decision at a later date (A.R.S. 38-431.02. k)

Fire Chief/Rick Schimkat provided update on the following:

- Equipment— We are continuing to work on engine 624, new parts being installed. We are also working on adding 50 gallons of water capacity to brush truck #626. We repaired wiring problem to headlight on support truck #627.
- Training Held training on two (2) Saturday's.
- Meetings Attended Attended a Mohave County meeting in reference to the Monsoon Season and potential flooding.
- Projects in the works Purchased three (3) tanks at 2500-gallon capacity, with plan for Flag
 Mine Road and off Ponderosa Drive. We continue to look at other sites for tanks.
 We will be purchasing the valves and fittings for four (4) tanks soon, to enable us to keep extra
 set.

We also need to hookup panel in well-house to enable us to run wells with a portable generator. Tank has also increased water level by 2 feet in the last two (2) weeks

- Other
 - Gary Osterberg has left PLFD, he has moved out of state and we collected PLFD equipment.
 - Mohave County will be delivering sand bags to Station #61.
 - The 10k gallon Helo Tank is being filled slowly by the BLM, it currently has about 500 gallons in it.
 - We have a new fire crew on the mountain as of today.
 - We have requested Stage #2 signage for our community. In addition, we will be formally requesting "Open Range" signage for Hualapai Mtn. Road, we requested this several years ago due to possible cattle on the road. Most people don't realize they are responsible for the cost of cows and damage if they hit the cattle.
 - We requested work to be done to the burn pile; the Parks Department has informed us they
 will pushup the pile and they will try to cleanup the burn pile and work on the road to the
 burn pile next week after the expected rains.
 - The board is concerned about the property next to Barb Graham's due to the number of dead trees on the property which creates a fire hazard to the community. Since efforts to communicate with the owner have failed, PLFD will be issuing a formal letter to property owner.

The Fire Chief, Rick Schimkat's report was accepted by the Board.
